Big Trip participant signing contract, henceforth referred to as '(the) participant'.

Article 1: Travel agreement

1.1 Participant takes part in the Big Trip from **April 29th 2024 until May 5th 2024.**

1.2 Participant is a member of SV Machiavelli and has paid all fees associated with membership of the association.

1.3 Participant is aware of the fact that transport costs to the location of the Big Trip are included in the participant's fee and that the participant is on time for departure. In the event that the participant arrives too late, the costs of transportation to the location of the Big Trip will be incurred by the participant.



1.4 Participant is obligated to follow the Big Trip program, as determined by SV Machiavelli and as per the instructions issued by SV Machiavelli.

1.5 SV Machiavelli reserves the right to adjust the program of the Big Trip, both before and during the Big Trip - when SV Machiavelli deems this necessary.

1.6 Registrations are processed according to the principle of 'first come, first serve'. In the event that there are more registrations than available spots, persons will be placed on a waiting list.

Article 2: Payment

2.1 By signing this contract, the participant obligates themselves to pay a €600,- participant's fee.

2.2 When choosing to pay the entire fee at once, participants with a Dutch bank account are to pay the €600,- participant's fee through SV Machiavelli's website (www.svmachiavelli.nl) **before April 12th 2024 17:00**. Participants without a Dutch bank account are to pay the €600,- participant's fee in the Machiavelli room (B1.07) by card before **April 15th 2024 17:00**.

2.3 When choosing to pay in instalments, participants with a Dutch bank account are to pay the €300,- first instalment through SV Machiavelli's website (www.svmachiavelli.nl) **at the moment of buying a ticket**, the participant is to pay the remaining balance of €300,- before **April 24th 2024 17:00** in the Machiavelli room (B1.07) by card. Participants without a Dutch bank account are to pay the first instalment of €300,- in the Machiavelli office (B1.07) by card before **April 5th 2024 17:00**. The participant is to pay the remaining balance of €300,- before in the Machiavelli room (B1.07) by card before **April 24th 2024 17:00**.

2.3 SV Machiavelli is authorized to replace the participant with another person on the waiting list.

Article 3: Cancellation by the participant

3.1 If the participant decides not to participate in the Big Trip, the participant should send an email to international@svmachiavelli.nl to inform SV Machiavelli about this no later than **April 15th 2024 17:00**. First, Machiavelli will ask persons on the waiting list if they are still willing to participate. If there are no more willing persons on the waiting list, the participant may suggest a person to replace them. To do this, the participant must inform international@svmachiavelli.nl of this before **April 15th 2022 17:00**.



3.2 If the participant decides not to participate in the Big Trip and neither they nor SV Machiavelli does not find someone else to take the participant's place, the participant does not have the right of restitution of the participant's fee. If the participant has not paid at the moment of cancellation, the participant is still required to pay the participant's fee.

Article 4: Travel requisites

4.1 Participant is required to fill in the Travel Form with complete accuracy during registration.

4.2 SV Machiavelli is not liable for any damages incurred related to incorrect filling in of the aforementioned Travel Form mentioned in article 4.1.

4.3 If the participant does not fill in the Travel Form within 48 hours of signing up, SV Machiavelli reserves the right to replace the participant with a person on the waiting list.









4.4 Participant is required to bring all necessary travel documentation, including a **valid passport** and, if necessary, **valid visa documentation**. All costs for said documentation are to be paid for by the participant. SV Machiavelli does not accept any liability for these travel documents and cannot retribute the participant's fee in the case of a denied (e-)visa.

4.5 Participants **not** of the nationalities listed underneath have to apply for a visa. The participant is responsible for applying for their visa at the appropriate time. For the countries listed underneath, the participants are eligible to get a visa on arrival.

Article 6: Cancellation or shortening of the Big Trip

6.2 SV Machiavelli reserves the right to cancel the Big trip in cases of insufficient interest or any other reasons relevant to the success of the Big trip, including but not limited to the financial feasibility and/or unforeseen circumstances. Unforeseen circumstances are to be understood as:

- (civil) war, or a corresponding condition;
- disturbances, where firearms are used;
- nuclear reactions, no matter how and where;
- hi-jacking, strikes or terror;
- natural disasters;



- sicknesses and epidemics;
- And similar conditions or situations.

6.3 In the case of delaying or expediting the Big trip by SV Machiavelli, the participant remains obligated to fulfill this contract's obligations, including payment of the participant's fee.

Article 7: Compliance

7.1 SV Machiavelli reserves the right to send a participant home.

7.2 SV Machiavelli should formulate clear rules and inform the participants about these rules. When a participant does not comply with these rules or the terms of this contract, depending on the situation, point 7.1 will take effect.

7.3 When a participant is sent home, the costs for this will be incurred by the participants.

Article 8: Liability for damages

8.1 SV Machiavelli is not liable for compensation of damages caused by the participant during the Big Trip, whether these damages are caused by intentional act or negligence on part of the participant

Article 8: Other regulations and agreements

8.1 When the participant signs this agreement, they agree with all the conditions and agreements above.
